**SECTION 7: HANDLING AND STORAGE.**

**7.1 Precautions for safe handling.**

The fumes are heavier than air and can spread across the ground. They can form explosive mixtures with air. 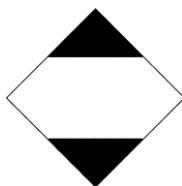
